Terms of Service

PLEASE READ ALL OF THE FOLLOWING TERMS OF SERVICE BEFORE USING THIS WEBSITE

A. General Terms

1. These Terms of Service ("ToS") govern users access to and use of the Vertabelo website available at <http://vertabelo.com> and any information, text, graphics, photos or other materials downloaded or appearing on the Vertabelo website ("WebSite") and Vertabelo service available in the WebSite (collectively referred to as "Service").
2. Service is intended solely for entity and all rights are granted under these conditions only for entity, who is not consumer within the meaning of Article 22¹ civil code. **If User is a consumer, please stop using the Services.**
3. These ToS (and documents mentioned below) are the entire and exclusive agreement between Vertabelo sp. z o.o. and and the entity that uses the Service (the "User") regarding the Service, unless a separate agreement in writing regarding the Service was made. In the event of a discrepancy between the agreement and these ToS, the agreement shall prevail the ToS.
4. These Service is operated and provided by Vertabelo sp. z o.o., ul. Filona 16, 02-658 Warsaw, Poland, registered in the register of entrepreneurs maintained by the District Court for the Capital City Warsaw, XIII Commercial Division of the National Court Register under the number 0000620026, NIP 5213728840. 5. Any complaints regarding the use of the Service User should report via our support site (<http://support.vertabelo.com/>). Vertabelo sp. z o.o. will consider complaints within 14 days of receipt.

B. Using of Service

1. The WebSite can be used by viewing its content anonymously. Please read the information on the Privacy Policy [<http://www.vertabelo.com/privacy-policy/>].
2. The using of the Service requires setting up and maintenance of an active User account.
3. The using of the Service may be in free of charge, in paid or in non-commercial model depending on the type of account activated by the User.

The fees for the use of the Service, payment policies and the scope of the functionality of User account are included in the price list.

4. Vertabelo is the service which allows you design your database online, especially:
 - a. Draw Entity Relations Diagrams (ERD) directly in your web browser (at this moment in Google Chrome only);
 - b. Store created database model on Vertabelo sp. z o.o. servers.
 - c. Generate SQL scripts from database model, which allows you create/delete database objects (tables, views, relationships etc.);
 - d. Download diagram of database model as an image;
 - e. Download/Upload of database model as an XML file;
 - f. Share database model with other Vertabelo users.

6. User has the right to use free and paid version of the Services as part of their online projects and as part of the solution offered commercially to third parties.

The data controller of your personal data is Vertabelo Sp. z o.o. (Filona 16 Warsaw 02-658 Warsaw, Poland (further on Vertabelo)).

For what purpose and on what basis we process your personal data?

Your personal data will be processed for purposes related to the conclusion and performance of the contract and for Vertabelo marketing purposes. The legal basis for the processing of your personal data above goals is art. 6 par. 1 lit. b) and art. 6 par. 1 lit. f) GDPR. The legitimate interest of Vertabelo. is the marketing of own products or services. Providing your personal data is not mandatory, but necessary for the implementation of the above purposes.

Vertabelo will entrust your personal data to other recipients entrusted with the processing of personal data on behalf of and for Vertabelo. In addition, Vertabelo will share your personal data with other recipients, if such an obligation will result from the law.

Your data will be transferred to third countries and international organizations as long as they meet adequate safeguards.

How long will we process your data?

Your personal data will be processed during the period of cooperation and after its completion for the period provided for by law, including the provisions of the Polish Civil Code and the Polish Accounting Act.

What rights do you have?

You have the right to:

- access to your personal data and receipt of copies of personal data being processed;
- rectification of incorrect data;
- request for deletion of data (right to be forgotten) in case of circumstances provided for in art. 17 GDPR;
- requests to limit data processing in cases specified in art. 18 GDPR;
- raising objections to data processing in the cases specified in art. 21 GDPR;
- transfer of supplied data, processed in an automated manner.

If you feel that your personal data is being processed unlawfully, you can file a complaint with the supervisory body (UODO, 2 Stawki Street, Warsaw, Poland).
